


Q1 Do you understand why you were asked to provide a stool sample for calprotectin when you first saw your GP?



Q2 Do you think it was acceptable to be asked to provide a stool sample?







Q5 Did you feel confident that your doctor gave you the right diagnosis?





I was then diagnosed with fibroids and was told that this was the cause of my bowel symptoms. 


